

BRITA • Yangzhou Its greatest strength lies in its comprehensive capabilities. With the support of the senior teaching staff and complete facilities of the National Tax Institute of STA, BRITA • Yangzhou has carried out 78 online and offline training programs since its establishment in 2019, effectively attracting more than 3,000 tax and fiscal officials to participate in the training cumulatively. The International Taxation Teaching and Research Department stands out in simultaneous interpretation, having undertaken the teaching tasks of courses such as "Tax Service" and "Chinese Tax System" for the BRITACEG since 2023. It has conducted high-quality knowledge training and academic research, provided comprehensive logistical support services, and received unanimous praise from trainees of various jurisdictions. Furthermore, it has made positive contributions to the promotion of important projects such as the designing of BRITACEG's curriculum system and the recording of online courses.

In July 2024, the BRITACEG organized The Event on the Development of the BRITAs in Yangzhou, bringing together 35 participants including representatives from the five BRITAs, international organizations, and tax administrations of China, Algeria, and other jurisdictions. The event focused on discussing the development of the BRITAs and promoting the growth of the BRITACEG. The keynote speeches were impressive and received unanimous approval, while the discussions were lively, with representatives from various countries and international organizations actively



contributing to collaborative plans. The field visits were highly representative, including tours of the Smart Taxation Experience Center of Jiangsu Province, the Yangzhou Intangible Cultural Heritage Treasure Museum, and the China Grand Canal Museum, where participants shared advanced taxpayer service experience and worked together to enhance tax administration capabilities.

It actively supports international tax work and serves enterprises going abroad, while focusing on enhancing communication and cooperation with other institutes and international organizations.

BRITACEG has set up five Belt and Road Initiative Tax Academies (BRITAs) since 2019. The BRITAs serve as important platforms for capacity building, offering training and academic exchange for tax and finance departments and professionals in the Belt And Road jurisdictions, and promoting international tax exchange and cooperation. To date, the BRITAs have been established in Yangzhou (China), Beijing (China), and Macao (China), as well as in Astana (Kazakhstan), and Riyadh (Saudi Arabia), creating a multilingual training network covering English, Chinese, Portuguese, Russian, and Arabic-speaking regions.

Looking ahead, the BRITACEG will continue to lead the five BRITAs to uphold the principles of open cooperation, mutual benefit, and win-win outcomes. The BRITACEG will work with all parties to continuously enhance the effectiveness of the BRITAs, invite a wide range of experts to participate in its lectures, and increase exchanges and cooperation with other international organizations. It will continue to build solid bridges for common progress and development for all parties to the BRITACOM and other Belt and Road partners, while also continuing to seek opportunities for expansion of the BRITAs. By working together with all stakeholders, the BRITACEG aims to build a growth-friendly tax environment and promote the capacity-building of all parties, thus hand in hand painting a new chapter of cooperation in tax administration among jurisdictions participating in the Belt and Road Initiative.



BRITA • **Astana** The most prominent feature of the Academy lies in strong professionalism. Since its establishment in 2019, BRITA • Astana has successfully held multiple online and offline training and seminar activities, covering topics such as "Transfer Pricing: Action Plan", "Information Exchange and Cross-departmental Cooperation to Combat Tax Offenses", "Implementation and Discussion of the BEPS Action Plan" and more. It has also actively coordinated with international tax experts through the BRITACEG to host specialized lectures on topics like "Management and Application of Big Data in Tax Collection and Administration" and about 1,000 fiscal and tax officials have participated in the training and gained valuable experience and emerging knowledge in the field of tax





In July and September, 2024, BRITA · Astana held two offline seminars on the themes of "Tax Incentive, Minimum Global Tax and Recent Changes in International Taxation" and "Transfer Pricing". Almost 100 tax officials from Kazakhstan and other state bodies participated in the training sessions. Recently BRITA • Astana started to participate in IOTA seminars and by doing this, provides opportunity for local tax officials to participate in international level seminars and develop their knowledge and skills. In 2024 BRITA• Astana plans to participate in 5 more webinars and train more than 200 local tax officials and other state bodies employers.



BRITA • **Riyadh** The most prominent characteristic is its distinct regional focus. As the knowledge training center of the BRITACEG in Arabic-speaking jurisdictions, the BRITA • Riyadh, which was announced to be established in September 2022, has successfully hosted "The Big Data Analysis" program and "The Concept and Policy of Double Taxation Treaties" program, attracting the participation of 74 tax officials. This marks the smooth transition of BRITA • Riyadh into its practical operation phase. Four training programs are scheduled to be hosted on the themes of "International Taxation and Double Taxation" "An Introduction to International Tax Treaties" "VAT Systems and Administration for Cross Border Trade in the Digital Economy" "VAT in the Financial Sector", with the participation of 100 tax officials.
