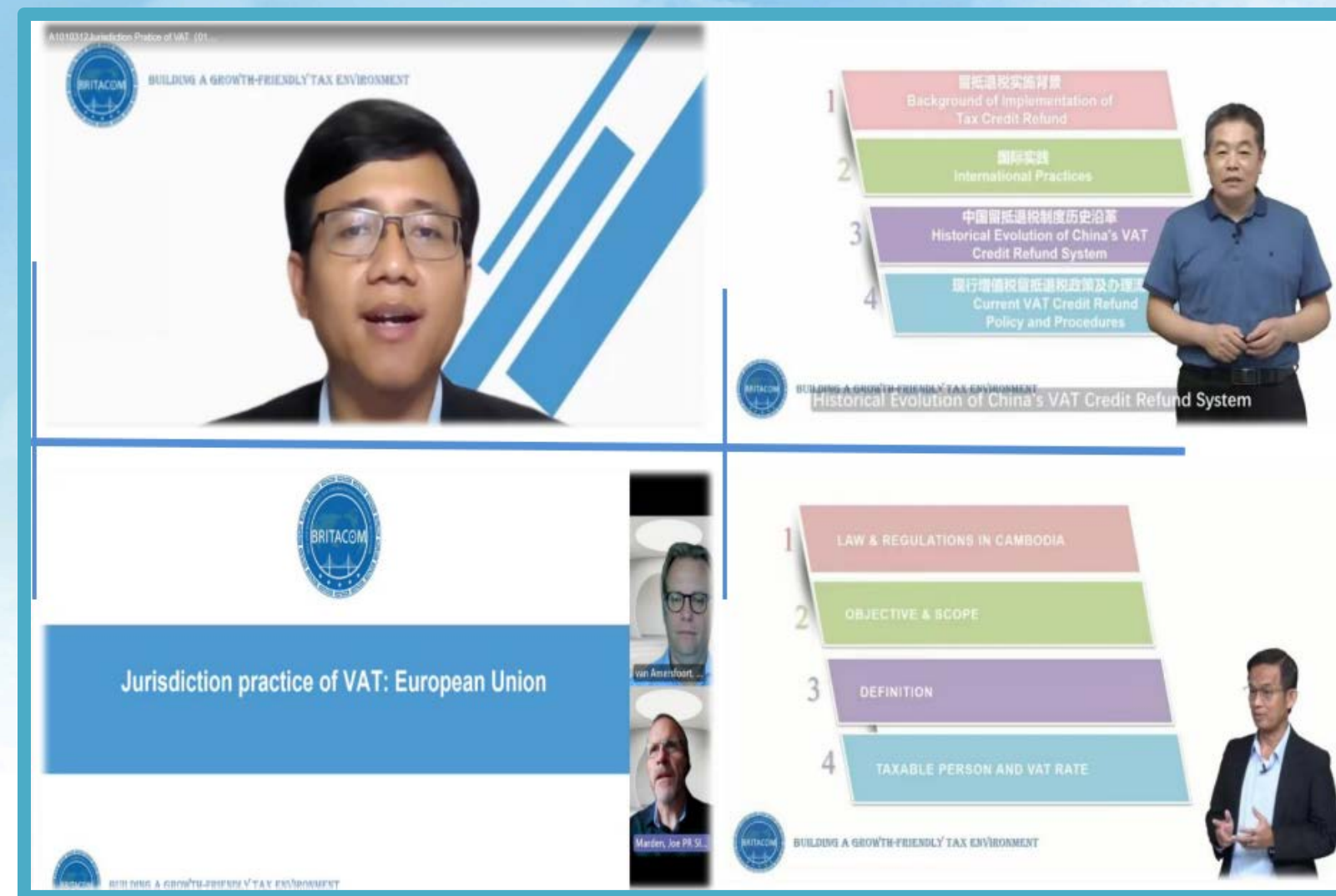

## “Onsite + Online” Integration to Stimulate Training Vitality

Leveraging the BRITA portal, we launched 65 online courses of four topics in accordance with the BRTIACEG Curriculum System 1.0, inviting over 100 fiscal experts and tax officials from 18 jurisdictions and international organizations to participate in course recordings. By now, nearly 70 online sessions were conducted, attracting more than 2,800 participants from over 30 BRI jurisdictions.
