

Programme Overview



The China-OECD LLM Programme on Taxation (COTP) was established through a co-operation among the **Xiamen University (XMU)**, the **State Taxation Administration (STA)** and the **Ministry of Finance (MOF)** of People's Republic of China, and the **Organisation for Economic Co-operation and Development (OECD)**.

The COTP is an advanced master programme on tax law, including international tax rules, policy and administration, which aims to provide tax officials and professionals with cutting-edge knowledge of international taxation, enable them to understand frontier issues and emerging developments in international taxation, and equip them with the skills to apply the theories and knowledge to address practical issues in international tax cooperation.

Programme Duration and Award of Degree



The COTP is a two-year, English-taught, LLM programme. Most of the courses and learning tasks in the programme will be completed at the XMU campus. In the first semester of the second academic year, students will have the opportunity to stay and take courses at the STA National Tax Institute in Yangzhou. The graduates will be granted a master degree in the Fiscal and Tax Law.







Field Research in China



Each year, students from different classes conduct two - week field research in July and November. They visited major cities such as Beijing, Shanghai, Guangzhou, Foshan, Nanjing, Suzhou, Taiyuan, Yuncheng, Fuzhou and Quanzhou.

During the visits to tax services, enterprises, and cultural venues in these cities, they enhance their understanding of China's tax practices, cultural and social landscapes, and improve their cross - cultural communication skills.

Internships in International Organizations



OECD Internship Program

Based on the Memorandum of Understanding, the OECD offers headquarters internship opportunities for COTP students. Since 2025, Xiamen University has sent 4 students in two batches to the Centre for Tax Policy and Administration (CTPA) of the OECD for a 3-month internship, facilitating students' access to the international tax research and practice platform.



Future Prospects


