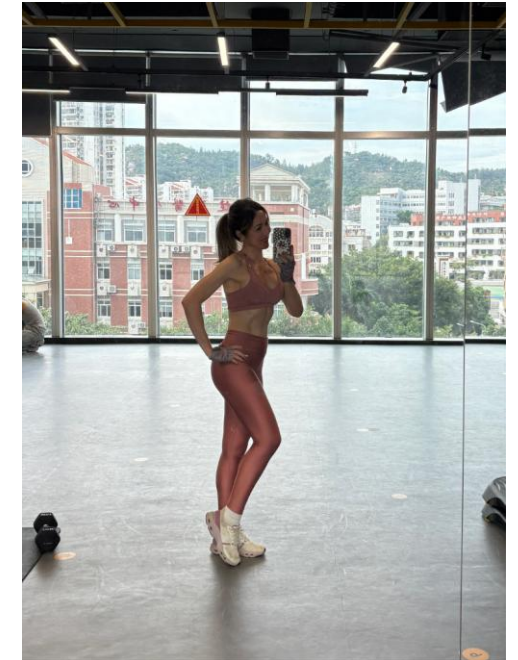

- Balance between **academic commitments** and **regular physical activity**.

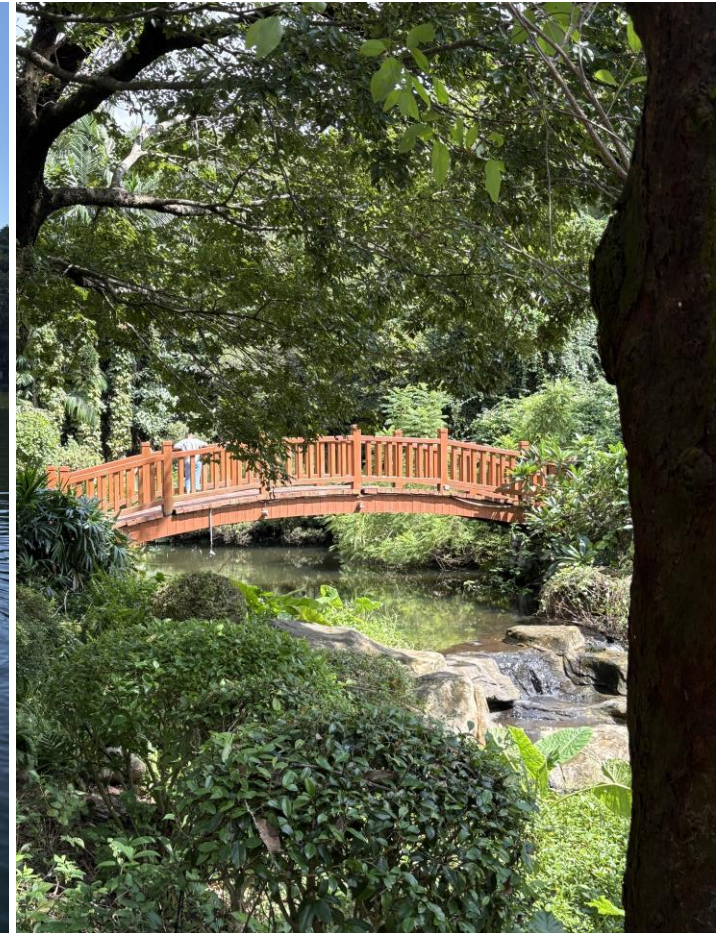

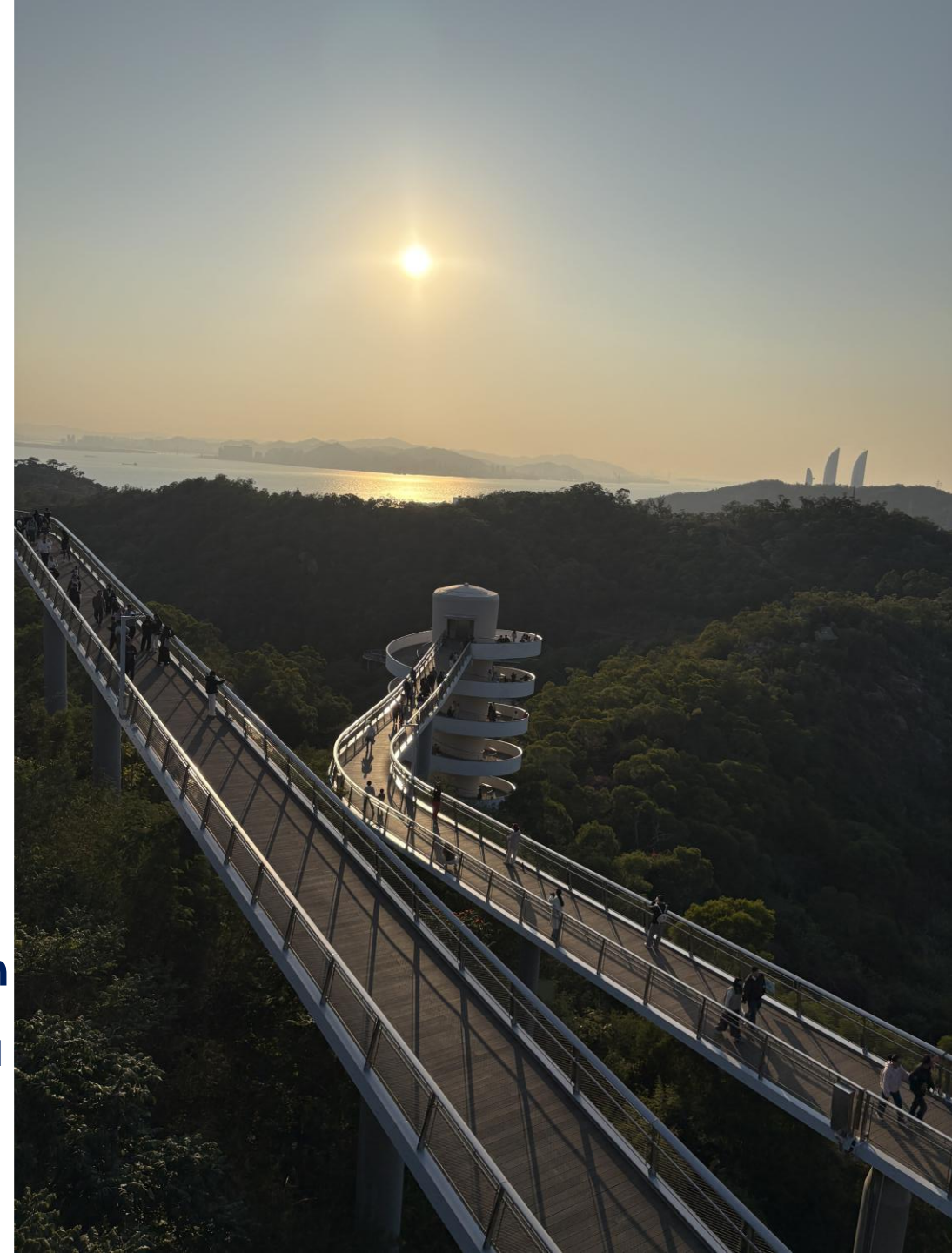
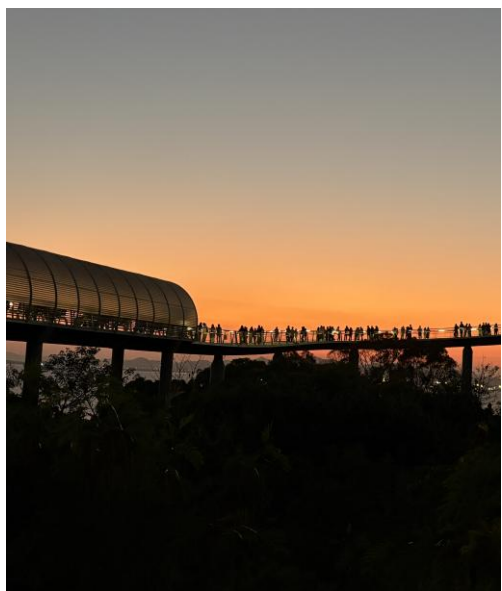

Application Requirements and Scholarship Benefits

Eligibility & Profile

- Citizen of a developing country (non-Chinese), under 45
- Bachelor's degree or above in law, public finance, taxation, financial management, accounting or other relevant areas.
- With at least three years' working experience.
- English proficiency (IELTS \geq 6.0 / TOEFL \geq 80)
- Good physical and mental health

Application & Documents

- Online application via CSC / Submission offline to be ECCO of Chinese Embassy in host country
- Study plan, CV, diploma, transcripts
- Two recommendation letters
- Passport, medical exam, criminal record certificate
- Official recommendation via ECCO

CSC Scholarship Coverage

- Full tuition waiver
- Free on-campus accommodation
- Monthly stipend
- Medical insurance
- One-time settlement allowance
- Round-trip international airfare
