“Moáther”/influencer Package

- The Moáther Package, launched by the FTA in 2025, is a package tailored to support content creators and influencers in meeting their tax obligations.
- The FTA, in collaboration with stakeholders, works to raise tax awareness and simplify understanding of tax laws and procedures.
- Key features:
 - It includes access to educational materials and useful resources, and reasonably priced tax agents, to help them understand their tax obligations.
 - It offers innovative tools and accounting software, developed with FTA’s partners, to enable flexible and convenient tax compliance.
 - It promotes voluntary compliance through easy-to-use solutions aligned with international best practices.
 - It supports the UAE’s vision of a transparent, fair, and sustainable tax system for the digital economy.



InnoVATes and InnoTAX 2025 AI Hackathon

- The FTA hosts the InnoTAX Hackathon annually to foster innovation in the tax sector.
- During the UAE Year of Community 2025 and as part of the UAE InnoVATes, FTA was recognised by the "Maskan" app, which facilitates VAT refunds for homes built by UAE nationals.
- The FTA also launched the InnoTAX 2025 AI Hackathon, focused on leveraging artificial intelligence to drive smart, future-ready tax solutions.
- This collaborative platform brings together AI experts, data scientists, tax specialists, entrepreneurs, and students to co-create intelligent tools that enhance tax compliance, improve taxpayer experiences, and modernise tax administration across the UAE.
