





Advantage of DET Invoice

(1) Simplified invoice acquisition process

Taxpayers no longer need to pre-purchase dedicated tax control equipment.

The application for specific invoice number segments is cancelled.

The system automatically assigns the total invoice amount limit to taxpayers.



BUILDING A GROWTH-FRIENDLY TAX ENVIRONMENT

Advantage of DET Invoice

(2) More convenient invoice issuance and use

- Operations such as issuing, delivering, verifying, and selecting the usage is in a "one-stop" manner.

- Abolish specific formats, which makes delivery more convenient.

- Display differently according to different businesses, provide higher-quality personalized services.



Advantage of DET Invoice

(3) More precise risk control

- 1 Fully online mode, real time storage
- 2 National standards, comprehensively collected
- 3 Risk scanning, improves taxpayers' compliance with tax laws





Characteristics

01 Hundreds of millions of registered users

02 One of the largest government service applications in China

03 Annual individual income tax declaration exceed 100 million



BUILDING A GROWTH-FRIENDLY TAX ENVIRONMENT

Annual individual income tax declaration

Tax-related data throughout the year and from multiple places are collected automatically.

Data Collection

01

"Single-profile-based" Tax File

A "Single-profile-based" tax file is constructed, providing data support for tax declarations.

The authenticity of data is verified against multiple external departments' information.

Data Verification

System Trial Calculation

The system background automatically conducts a trial calculation.

04

Confirm with one click.

Pre-Filling Service

05

Pre-fill the Declaration

List the pre-filled data of items such as income and expenses.

06

Taxpayers check and confirm the pre-filled data and complete the declaration.
